
Before you get started, ensure that all the drivers required for your USB device(s) are installed. LEX = Local Extender, REX = Remote Extender

**1** Recommended:


Use included Cable Pulling Eye to route included Link Cable through a conduit.



Place extenders where desired and connect the included Link Cable to the LINK ports on the LEX and REX.



3 Connect the LEX HOST USB port to the computer's USB-C port using the included USB-C Cable.



If Power LED illuminates amber indicating a warning, plug an Icron approved 5V 3A power supply (not included) into the LEX.

The repaired or replaced item will be shipped to you, at Icron's expense, not later than thirty days after Icron receives the defective product.
