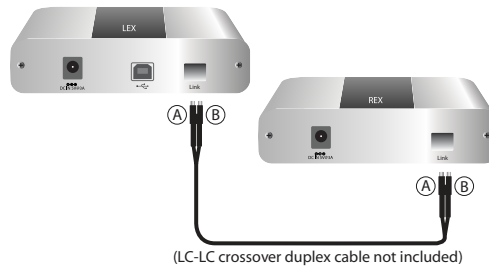

Before you get started, ensure that all the drivers required for your USB device(s) are installed.
LEX = Local Extender, REX = Remote Extender

- 1** Place extenders where desired and connect the fiber cable to the Link ports (SFP) on the LEX and REX.



Max 500m multimode fiber for RG2224
Max 10km singlemode fiber for RG2244

- 2** Connect the LEX to the computer using the included USB cable.

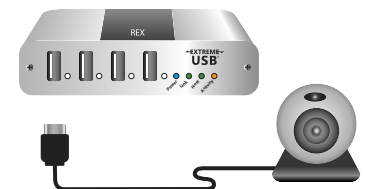


Note: Power adapter is not required at the LEX for normal operation.

- 3** Connect the REX to the AC adapter and plug into a power source.



- 4** Attach USB device(s) to the REX.
