## Network Connect

- 1 Place the LEX where desired and connect a CAT 5e/6/7 patch cable from the Link port (RJ45) to a network switch or wall network port connected to a switch.

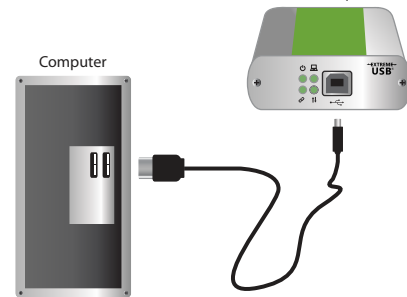
Local Extender (back view)



Max 100m between network devices

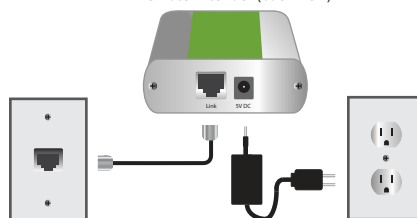
- 2 Connect the LEX to the computer using the included USB cable.

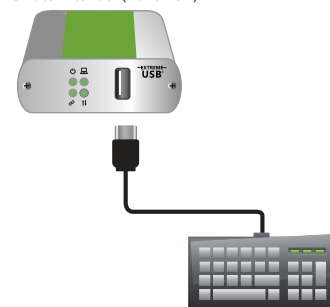
Remote Extender (back view)

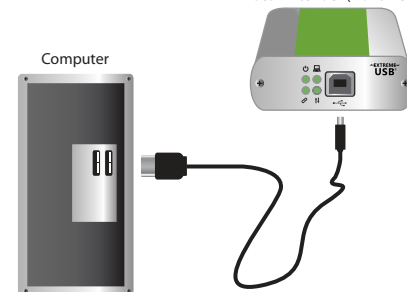

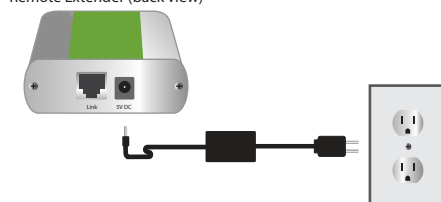
- 2 Connect the LEX to the computer using the included USB cable.

Local Extender (front view)



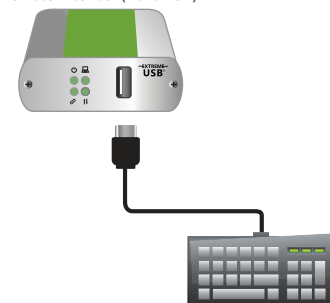
- 3 Connect the REX to the AC adapter and plug it into a power source.
