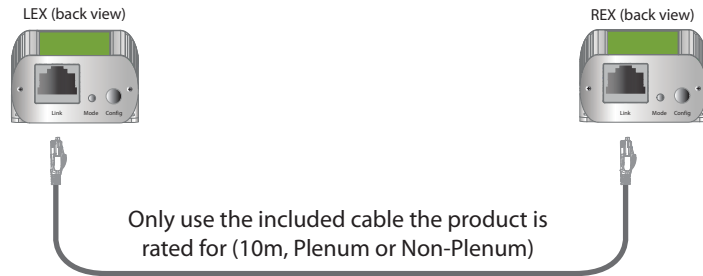


Before you get started, ensure that all the drivers required for your USB device(s) are installed.
LEX = Local Extender, REX = Remote Extender

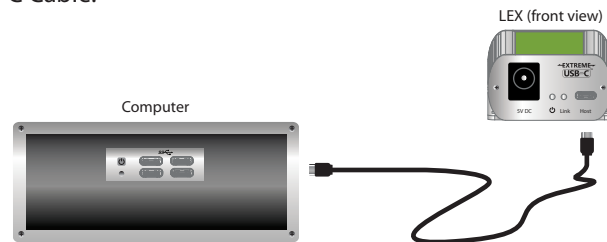
- 1 Recommended:
Use included Cable Pulling Eye to route included Link Cable through a conduit.



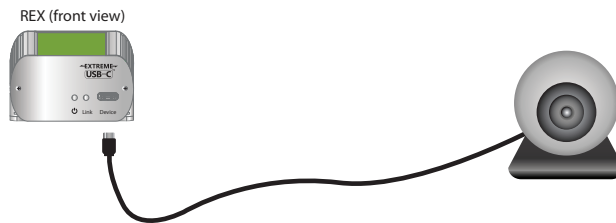
- 2 Place extenders where desired and connect the included Link Cable to the LINK ports on the LEX and REX.



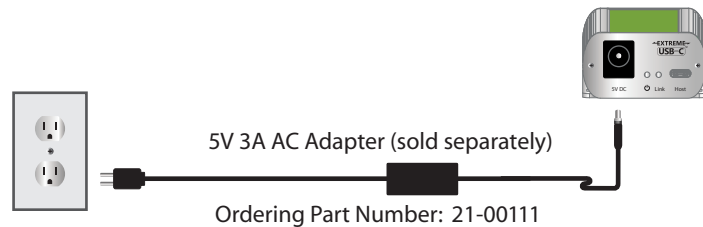
- 3 Connect the LEX HOST USB port to the computer's USB-C port using the included USB-C Cable.



- 4 Connect the USB Device to the REX DEVICE USB port.



- 5 If Power LED illuminates amber indicating a warning, plug an Icron approved 5V 3A power supply (not included) into the LEX.
